The First Record of *Leiosolenus simplex* (Iredale, 1939) (Bivalvia: Mytilidae) Boring into *Plesiastrea versipora* from Minamata Bay in Japan

In the family Mytilidae, six genera are known to include rock-boring species: Adula, Botula, Fungiacava, Gregariella, Leiosolenus and Lithophaga (Kleemann, 1990). Species of all except Fungiacava are distributed in Japan: Adula spp. are found north of the Boso Peninsula, Honshu and northward and bore into mudstone; Botula, Gregariella, Leiosolenus and Lithophaga spp. are found south of the Boso Peninsula and bore into dead corals, limestone or calcareous sandstone (Habe, 1977; Higo & Goto, 1993; Kurozumi, 2000). It is known that all Fungiacava species and some Leiosolenus species bore into living corals (Kleemann, 1990). In Japan, however, the distributions and habitats of these species are not yet clear.

Leiosolenus simplex was collected from living Plesiastrea versipora (Anthozoa: Scleractinia) distributed in Minamata Bay, Kumamoto Prefecture, Kyushu, and is recorded for the first time in Japan. In this paper, the shell morphology and habitat of this species are described, and the classification of *Leiosolenus* is discussed.

Taxonomy

Family Mytilidae Rafinesque, 1815

Genus Leiosolenus Carpenter, 1856

Type species: *Leiosolenus spatiosus* Carpenter, 1856

Remarks: Wilson (1979) and Wilson & Tait (1984) suggested that the genus *Lithophaga* be classified into two groups on the basis of the presence of incrustations on the shell surface. Oliver (1992) classified the group with incrustations as the genus *Leiosolenus* and that without as *Lithophaga*. However, this classification has not been accepted widely, because the phylogenetic relationships between the two groups were not described sufficiently. On the basis of molecular phylogenetic analysis, Owada (2007)

concluded that *Leiosolenus* and *Lithophaga* are monophyletic genera and that the group of *Leiosolenus* plus *Lithophaga* is paraphyletic. Consequently, the classification proposed by Oliver (1992) is appropriate and has been adopted in this study.

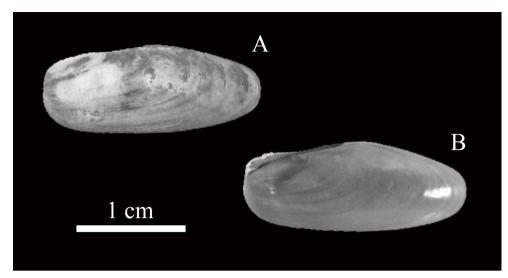


Fig. 1. Leiosolenus simplex. A. outer surface of right valve. B. inner surface of left valve.

Leiosolenus simplex (Iredale, 1939) (Fig. 1)

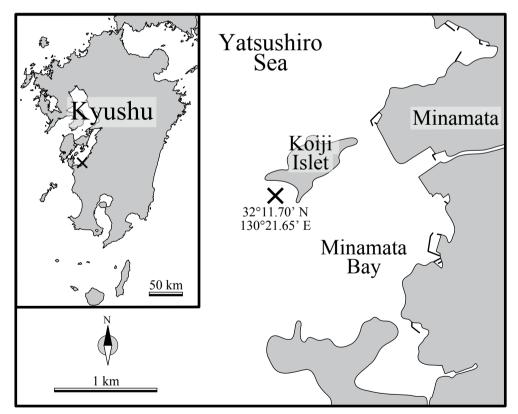


Fig. 2. Location of the sampling point. The specimens were collected from the place marked as "x"

Materials: Sixteen individuals were collected from Minamata Bay on 24 May 2007 (Fig. 2). The specimens were extracted from living *P. versipora* inhabiting the seafloor at a depth of 9-10 m using a hammer and chisel. These specimens and substrata were deposited at Kanagawa University.

Measurements: (Shell length × height × width in mm): #1, 19.8 × 8.1 × 7.1 (Fig. 1); #2, 19.8 × 8.0 × 7.0; #3, 16.3 × 7.5 × 6.5; #4, 16.0 × 7.1 × 6.2; #5, 15.3 × 6.3 × 5.4; #6, 15.1 × 7.1 × 5.8; #7, 14.9 × 6.9 × 6.3; #8, 14.4 × 6.2 × 5.6; #9, 14.3 × 5.6 × 5.1; #10, 14.0 × 6.2 × 5.4; #11, 13.2 × 6.0 × 5.3; #12, 13.0 × 5.9 × 5.4; #13, 12.9 × 6.1 × 5.3; #14, 12.4 × 5.8 × 4.9; #15, 11.9 × 5.2 × 4.6; #16, 10.5 × 4.4 × 3.7.

Description: Shell small for genus, rarely exceeding 20 mm in length and 7 mm in height, thin, cylindrical, slightly tapering posteriorly. Umbo near anterior end. Anterior and posterior margins rounded. Dorsal margin elevated. Ventral margin slightly convex. Hinge line straight. Periostracum pale yellowish, covered by thin, chalky calcareous incrustation. Siphon darkly pigmented.

Remarks: L. simplex can be distinguished from Leiosolenus lessepsianus (Vaillant, 1865) because it has an inflated shell form and darkly pigmented siphon. L. simplex also resembles the juvenile of Leiosolenus curtus (Liscke, 1874), but the incrustation does not protrude from the posterior margin, and the color of the periostracum is pale yellowish.

Distribution and habitat: L. simplex bores only

into living corals. In the Great Barrier Reef, it bores into Favia amicorum, F. favosa, F. pallida, Goniastrea retiformis, Lobophyllia corymbosa, L. costata and Symphyllia nobilis, and in the Red Sea, it bores into Goniastrea pectinata and G. retiformis (Kleemann, 1980). In Japan, L. simplex bores into P. versipora. It is also found in Hong Kong, but details of the coral into which it bores into are unknown (Scott, 2003).

Discussion

L. simplex has hitherto been known to be distributed in the Great Barrier Reef and the Red Sea and to bore into several species of living corals. P. versipora is not rare in coral reefs in the tropical Indo-West Pacific; however, L. simplex is reported to bore into this species for the first time in this paper. In Minamata Bay, P. versipora has been known since at least 1950; L. simplex has been found to occur here only since 1996 (Yamamori & Ise, personal communication). These facts may suggest that the environmental conditions of Minamata Bay have changed such that a suitable habitat has been created for L. simplex, which has undergone adaptation in the past couple of years to bore into P. versipora.

Apart from *L. simplex*, which bores into *P. versipora*, boring mytilid bivalves have been found in the living corals *Galaxea fascicularis*, *Montipora digitata*, *Platygyra ryukyuensis* and *Stylophora pistillata* from Sesoko Islet, Okinawa Prefecture, Ryukyu Islands; all were identified as *Leiosolenus malaccanus* (Reeve, 1858) (Moretzsohn & Tsuchiya, 1992). However, this identification is doubtful, because *L. malaccanus* bores only into dead corals (Wilson, 1979; Kleemann, 1984).

Species diversity and biomass of rock-boring mytilids are high in tropical and subtropical areas. In a coral reef they play an important role, especially in ecology. For example, Highsmith (1980) and Scott & Risk (1988) indicated that the destruction of hermatypic corals by rock-boring mytilids promotes the regeneration of the coral reef, and Kleemann (1996) and Nishihira (1996) suggested that the boreholes of rock-boring bivalves supply cryptic habitats for various animals. Furthermore, coevolution between mytilids boring into living corals and the host corals has been suggested (Brickner *et al.*, 1993; Mokady *et al.*, 1993; Mokady *et al.*, 1994).

Coral reefs in Japan are suitable for these studies, because the species diversity of corals and bivalves in these ecosystems is relatively high. In the initial stages, sufficient information should be gathered on bivalves boring into living corals.

水俣湾のコマルキクメイシから採集 されたイガイ科穿孔性貝類の1種

熊本県水俣湾に生息するコマルキクメイシ Plesiastrea versipora から日本初記録のイガイ科穿 孔性貝類である Leiosolenus simplex (Iredale, 1939) (マメイシマテ・和名新称)が採集された。本種 は生きたサンゴにのみ穿孔し, 殻長 20 mm, 殻幅 7 mm を超える個体は少ない。殻形は円筒形であ り, 殻表の沈着物 (二次殻) はチョーク状で薄く, 後縁から突出しない。

本種がコマルキクメイシに穿孔することは本稿 で初めて報告された。コマルキクメイシは 1950 年以前から水俣湾に生息しているが、本種が穿孔 するようになったのは 1996 年以降である。これ らのことから、現在の水俣湾の環境が本種の生息 に適していること、この 12 年間で本種がコマル キクメイシに穿孔できるように適応した可能性が 示唆される。

シギノハシガイ属 Lithophaga は二次殻の有無 に基づいて2つのグループに区別され,それぞれ のグループは異なる系統を持つことが知られてい る。本稿では二次殻を持つグループをイシマテガ イ属 Leiosolenus として記載した。
